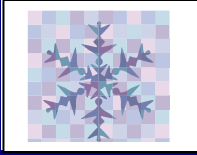

## DOG OWNERS

If you own a dog, please remember that you must keep them on a leash or under strict voice control while out in the streets, or on walking paths. In light of recent reports of dog attacks, we ask that owners remain vigilant in controlling their dogs. Please contact the Teton County Sherrif for any altercations you may have with a dog in the community. They are trained to deal with these situations.

Additionally, please clean up after them **everytime** – a little work now will go a long way! Please do your part to be sure dogs are appreciated in our neighborhood and be a considerate neighbor.

A big shout out and thank you to those dog owners who have been proactive in clean-up and roaming efforts – we sure do appreciate it!

## 2024 BUDGET

We are happy to report that all of the budgets in Teton Springs were approved. Thank you to all of the homeowners who returned their ballots. The budgets are posted on the Teton Springs website. There is no change in dues this year.

## SNOW PLOWING

The snow plow contractors will come through the subdivision and work on plowing the streets first. After the streets are clear, driveways should be unplugged. If there is an issue with your driveway, please notify Grand Teton Property Management Monday through Friday between 9am and 5pm.

When clearing your driveway please remember to have your snow piled on your property away from the street. Finally, **please do not park on the roadways**. The snow plows need the streets free from cars to be able to effectively clear the snow. This is especially important for Mountain Meadows where there is very little space to maneuver.

## SNOW MACHINES

The Teton Springs Homeowners Association would like to remind all owners and their guests of the neighborhood rules as they apply to snow machines:

~Snow machines **cannot be operated** within the Teton Springs subdivision (this includes on the Golf Course).

Snow machines must be on a trailer coming into and out of the subdivision.

~Snow machines **cannot be stored** on any driveway.

They can however be stored within an enclosed garage. Please feel free contact GTPM if you have any questions or need any clarification on these guidelines.

## REMINDERS

**Wildlife:** We are fortunate at Teton Springs to share our habitat with others including bears, coyotes, moose, elk, deer, fox, raccoons, wolves and more. Please keep in mind that these animals are wild and should not be fed nor should they be approached. Please remember to keep your dogs on a leash for their safety as well as for the safety of the wildlife.

**Trash:** Please do not leave your trash out overnight either before or after your scheduled Friday pick-up.

**Speeding:** Please be courteous and mindful of your speed throughout all of Teton Springs. The speed limit is 25 mph for the safety and welfare of all residents and guests.

**Ponds:** No swimming, boating or ice skating on any lake or pond. Please keep dogs out of the water as well for the health of the ponds and lakes.

## DID YOU KNOW?



The start of the winter season is marked with hot cocoa, blustery weather and, in this neck of the woods, outdoor activities aplenty! Did you know that the air doesn't need to be moist to produce large amounts of snowfall? It is the air itself that adds to a bank of fluffy snow. That is why an inch of rain equals about 10" of snow. Did you know that snow falls about 1 to 6 feet per second and come in all sizes ranging from slightly smaller than a penny to the width of a strand of hair? In 1887 witnesses to a snow storm in Ft. Keogh, Montana claimed to see milk-pan sized crystals falling from the sky; that would be a snow flake about 15" wide (the largest ever spotted). While our roads are typically sanded to detract animals from approaching them, salt is more commonly used to melt the ice from roadways. As a matter of fact, more than 22 million tons of salt is used on US roads each winter! We hope you have a wonderful winter and wish you an abundance of snow and fun here in the Tetons!
